# OUR PURPOSE

Together we have the strength to trace a common path, where there is a necessary balance between the growth and well-being of the population, their energy needs and the preservation of ecosystems. Even in the context of response to social emergencies, such as those resulting from the Covid-19 pandemic or the armed conflict in northern Mozambique, in addition to the cooperative humanitarian aid that we promote, our focus continued to be directed at creating the conditions for access to inclusive and equitable education. Helping to build infrastructures to support education, investing in merit-based scholarship programmes and mentoring programmes, and in initiatives to integrate the most vulnerable families into host communities. Thus, enabling the necessary basic conditions for children and young people to return to school.

In Portugal, we continued to invest in education programmes focused on empowering young people to respond to the climate emergency, valuing their more sustainable behaviours and attitudes and promoting in-school environment entrepreneurship and innovation. In 2021, we directly impacted the lives of more than 37 thousand people, worked together with our social partners and relied on the invaluable commitment of 797 Galp volunteers, who brought their energy, skills and human warmth to our communities. To all of them, a big thank you.

A special word of appreciation to the founding group, the Galp Group, and in particular, to the three sponsoring companies (Galp Energia SGPS, S.A., Galp Gás Natural, S.A. and Petrogal, S.A.), which provided *Fundação Galp* with the financial means necessary to develop its activity in 2021. ## GOVERNANCE CODE OF ETHICS

Fundação Galp is a non-profit private foundation of social interest, established in 8 January 2009 ,under Código Civil Português and complying with the requirements from "Lei-Quadro das Fundações", having as its founders the following entities:

- Galp Energia, S.G.P.S., S.A.
- Galp Exploração e Produção
  Petrolífera, S.A.(since 23.06.2021
  designated "Galp West Africa, S.A.")
- Petróleos de Portugal Petrogal, S.A. (since 06.09.2018
- designated "Petrogal S.A.")
- Galp Gás Natural, S.A.
- Galp Power, S.A. (meantime merged into Petrogal, S.A. with effects as of 02.11.2021)
- Galp Energia, S.A

On 22 July 2018, Fundação Galp was granted the status of public utility for another five years. Also, on the institutional theme, it should be noted that *Fundação Galp* has been obtaining statements of recognition of the cultural interest of its various activities, issued on 23 October 2013 by the Portuguese Secretary of State for Culture and on 30 December 2016 and 7 February 2018 by the Portuguese Minister for Culture. Fundação Galp is a legally independent entity, with its own governance model, defined in its Articles of Association. However, it is an entity linked to the organisational culture of the founding group with which it shares its name.

Fundação Galp operates primarily in the areas of energy and environment, education and culture, and social development. In its Code of Ethics, approved and published in 2018, *Fundação Galp* outlines the fundamental ethical guidelines for its operations, from a perspective of assuming ethical and conduct commitments towards:

- (1) the people of the Foundation;
- (2) the will of its founders and from other funders of Fundação;
- (3) the Foundation's partners;
- (4) the Foundation's suppliers;
- (5) the beneficiaries of the Foundation's activity;
- (6) the society in general, present and future.

The Code of Ethics states the importance of clearly defining the principles and responsibilities that *Fundação Galp* recognises, accepts, shares and assumes in its relations with its people and all other stakeholders in the foundation's purposes, considering the specific nature of its institutional mission. It enshrines, for each of the situations listed therein, commitments and responsibilities, but also, and equally importantly, how they are to be legally implemented.
